

QUAY QUARTER SYDNEY / SPEND \$10. GET \$10. GIFT CARD GIVEAWAY

Terms and Conditions

1. These terms and conditions apply to entrants to the 'SPEND \$10. GET \$10. GIFT CARD GIVEAWAY' Centre Offer ("Offer"). Participation in this Offer is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexu Office and Industrial Pty Ltd (ABN 44 099 105 094). The address is 50 Bridge St, Sydney NSW 2000 and Loftus Ln, Sydney NSW 2000.
3. This Offer will be conducted at Quay Quarter Tower, 50 Bridge St and Quay Quarter Lanes, Loftus Ln, Sydney. Phone 0431 024 726 ("Centre").

ELIGIBILITY

5. This Offer is only open to residents of New South Wales aged 18 years or over who are able to attend the Centre at 7:00am – 5:00pm AEST between Monday 13 – Friday 17 July 2026 and Monday 20 - Friday 24 July 2026.
6. The following individuals are ineligible to enter the Offer:
 - a. Centre Management of the Promoter, or any of the retailers in the participating Centre/s or any of the Promoter's agencies that are associated with the Offer
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's offers.

OFFER PERIOD

7. This Offer runs daily between 7:00am and 5:00pm AEST on Monday 13 – Friday 17 July 2026 and Monday 20 - Friday 24 July 2026, or until gift stocks run out, whichever is first ("Offer Period").

CLAIM INSTRUCTIONS

8. To claim, eligible individuals must, during the Offer Period:
 - a) Spend \$10.00 or more at any Quay Quarter Tower or Quay Quarter Lanes store or venue in one transaction. ("Qualifying Spend");
 - b) Locate and scan the QR code on promotional material displayed throughout the Centre with your smartphone or visit <https://www.quayquartersydney.com.au/whats-on/spend-10-get-10.html> ("Website"), complete and submit the online claim form, including uploading the image of your itemised Qualifying Spend receipt dated the same day as entry, and providing your name, email address, phone number and all other requested information and agree to the terms and conditions;

- c) Upon successful validation of your claim (allow up to two business days), you will receive an email to inform you of successful validation and SMS from LocalCard with instructions on how to claim your \$10.00 Quay Quarter digital gift card;
 - d) If your claim is unsuccessful, you will be notified at the time of submission or by email within two business days.
9. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting a claim, including having the requisite photograph capability.
10. Winners have 30 days to activate their digital gift card from date of successful entry, and up to 90 days to redeem the balance from the issue date before the prize is forfeited.

CLAIM LIMITS

11. There is a limit of one (1) claim per eligible person per week.
12. Original purchase receipt must be presented as proof of purchase to claim a digital gift card – no re-printed or repeated receipts will be accepted.
13. The receipt must be dated the same day as competition entry date (cannot provide a receipt from a previous day).
14. Only one (1) receipt can be presented to qualify spend for the Offer.
15. Limited number of gift cards are available each day.

19. Any ancillary costs associated with redeeming the Quay Quarter digital gift card are not included. The digital gift card must be activated within 30 days of issue and is valid for 90 days after activation. At expiry of the digital gift card any unused balance will be forfeited. Eligible Customers will not receive notice prior to expiry.
20. The Digital Card can only be used at participating Quay Quarter retailers, see Annexure 1.
21. To activate your Digital Card:
- a. You will receive an email from Quay Quarter advising you of your successful validation, followed by a text message from LocalCard within a few minutes (up to 48 hours in some cases).
 - b. Click on the link in the text message from LocalCard to 'Redeem' your Quay Quarter digital gift card. You have 30 days from the issuance date to activate the digital gift card.
 - c. You must have an Australian mobile number to activate.
 - d. You may need to enter your mobile number and the activation code that was provided in the SMS.
 - e. When your Quay Quarter digital gift card is displayed, click "Add card to wallet" and follow the prompts to add your digital gift card to your phone's mobile wallet (e.g. Apple Pay, Google Pay or Samsung Pay).
 - f. Use the card in the mobile wallet for purchasing goods and services in the participating stores within the Shopping Centre associated with your claim.
 - g. You have 90 days to redeem your gift card from the date of issue. You can check the balance and the expiry date of your card by returning to the link in the SMS and following the steps. Should you have multiple cards, you can view and manage all cards in your digital wallet.

UNCLAIMED GIFTS

22. There will be no unclaimed gifts, as gifts will be automatically awarded to successful claimants, via the mobile number associated with their entry. It is a claimant's responsibility to ensure that they enter their mobile number correctly. If they fail to enter their mobile number correctly, the gift will be forfeited.
23. Upon successful validation of details, winners have up to 30 days from the date issued to access and activate their digital gift card and 90 days to use it before prize is forfeited.

PROOF OF PURCHASE

24. You must keep your Qualifying Spend itemised receipt as proof of purchase of your claims. Your Qualifying Spend receipt must clearly identify the vendor and location, the products purchased (of which

must be/comprise the Qualifying Spend), the date of purchase (which must be during the Offer Period, before you claim), and whether the Qualifying Spend was made.

25. If you don't produce the above proof of purchase for your claim when asked, the Promoter may disqualify your claim and you will lose any right to a gift.
26. Proof of purchase must be identical to that provided by you with your claim.

 - c. once activated, the Digital Visa Debit Card will remain valid until the expiry date shown in the recipient's LocalCard web app at app.localcard.io, and after that date any unused balance will be forfeited and cannot be redeemed or refunded; and
 - d. the Promoter is not the issuer of the Digital Visa Debit Card, does not provide financial product advice in relation to the card, and accepts no liability for the conduct of Airwallex Pty Ltd or LocalCard or for any inability of the winner to activate, access or use the card, except to the extent of any liability that cannot be excluded under the Non-Excludable Guarantees.

GENERAL

29. You must not:

33. The Promoter is not responsible for any dispute between you and any person with whom you choose to, or choose not to, share a gift.
34. If any gift (or part of any gift) is unavailable due to reasons beyond the control of the Promoter, the Promoter at its discretion, reserves the right to substitute the gift (or that part of the gift) with a gift or part of a gift with an equal or higher value and/or specification, subject to any written directions from a regulatory authority if applicable.
35. Gifts, or any unused portion of a gift, are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified by the Promoter.
36. Participants consent to the Promoter using the participant's name, likeness, image and/or voice in the event they are a successful claimant (including photograph, film and/or recording of the same) in any media without remuneration for the purpose of promoting this Offer (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter or the Promoter's retailer(s).
37. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting participating retailers) and participants (including a participant's identity, age and place of residence) and to disqualify any participant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
38. If this Offer is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify a participant engaging in unauthorised intervention or fraud; or (b) to modify, suspend, terminate or cancel the Offer, as appropriate and if applicable, subject to any written directions from a regulatory authority.
39. If any dispute arises concerning the conduct of this Offer, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. However, the Promoter's decision is final, and no correspondence will be entered into.
40. Any cost associated with accessing the promotional website is the participant's responsibility and is dependent on the internet service provider used. The use of any automated claim software or any other

mechanical or electronic means that allows a participant to automatically claim repeatedly is prohibited and will render all claims submitted by that participant invalid.

If online or SMS claiming is available, you will receive a return message confirming your claim. You are responsible for your own costs associated with claiming. 42. The Promoter is not responsible for any tax implications arising from you claiming a gift. You should seek independent financial advice. If for GST purposes this Offer results in any supply being made for non-monetary consideration, you must follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.
43. Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act 2010 (Cth), as well as any other implied warranties under similar consumer protection laws in NSW ("Non-Excludable Guarantees").
44. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Offer, including without limitation:
 - a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any claim or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;
 - d. any variation in the gift value to that stated in these Terms and Conditions;
 - e. any tax liability incurred by a participant; or
 - f. use of the gift,

except for any liability which under statute, including under the Non-Excludable Guarantees, cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).

45. This Offer is in no way sponsored, endorsed or administered by, or associated with any social media platform, including Instagram or Facebook. You provide your information to the Promoter and not to any social media platform. You completely release any relevant social media platforms from any and all liability.

PRIVACY

46. In order to conduct this Offer, the Promoter needs to collect personal information about each participant and may for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, gift suppliers and, if required, to Australian regulatory authorities. Participation in the Offer is conditional on providing this information.
47. By participating, you consent to the Promoter using this information for promotional, marketing, publicity

and research purposes, including telephoning the participant or sending email or SMS messages provided that where required by the *Spam Act 2003* (Cth), the Promoter includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth). You also consent to receive email or SMS messages from the Promoter without any functional unsubscribe facility if they relate primarily to the conduct of this Offer. The Promoter may use your personal information for such other purposes as set out in the Dexus Group Privacy Policy, which is available at <https://www.dexus.com/general/privacy-policy.html>. Unless otherwise indicated by the Promoter, the Promoter may disclose personal information to entities outside of Australia, including in the United States, Europe and the Asia-Pacific region.

48. In order to facilitate the collection or redemption of gifts, you may need to provide your personal information to third parties (such as retailers) associated with this offer. The collection, use and disclosure of your personal information by such third party will be in accordance with the relevant third party's privacy policy. If you have marked the "opt-in" box on the claim form relating to a third party collecting your personal information, you consent to the storage of your personal information on the specified third party's database/s and the specified third party may use this information for future promotional and marketing purposes regarding their products and services including contacting you via electronic messaging provided that where required by the *Spam Act 2003* (Cth), the third party includes a functional unsubscribe facility in each direct marketing communication it sends you that you may use to opt-out of any further such communications and provided that the functional unsubscribe facility complies with the *Spam Regulations 2021* (Cth).
